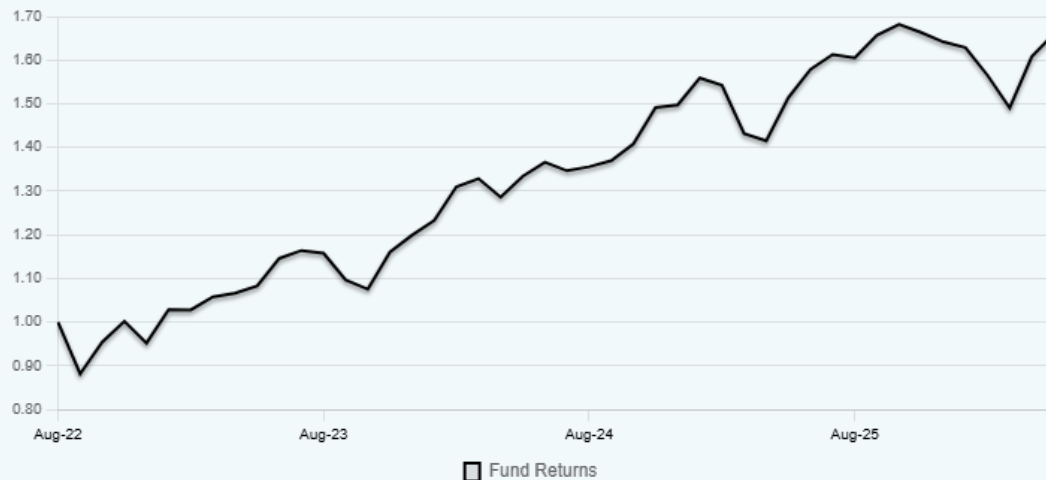
This is a discretionary managed account service¹ ("Account") investing globally through the use of multiple investment instruments.

The authorized investments include shares (including preference and ordinary shares), listed warrants, fixed income, unit trusts, closed-end funds, other collective investment schemes, investment trusts, business trusts, Exchange-Traded Funds, Exchange-Traded Notes and other related financial instruments listed on major stock exchanges. It also invests in cash equivalents and money market funds.

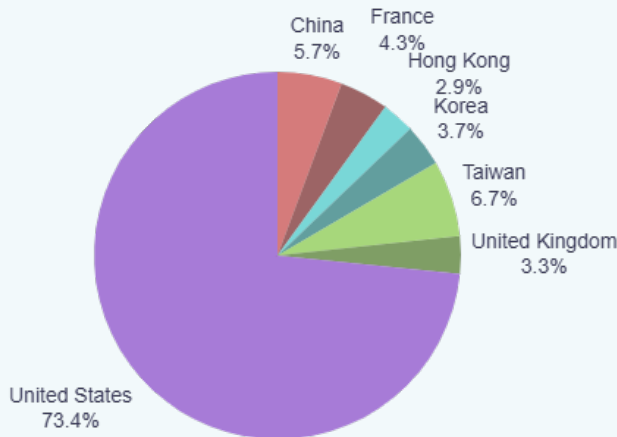

Commentary

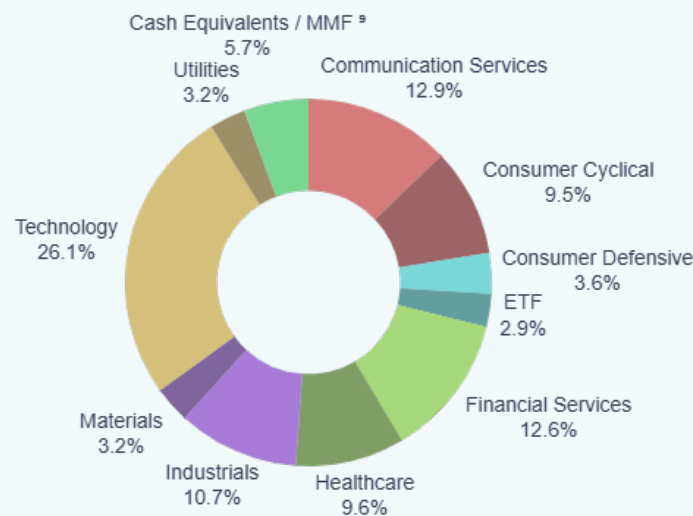
May saw continued strength across risk assets as stronger than expected earnings and guidance drove renewed optimism almost entirely within semiconductors and AI linked technology. Adjusted for an approximate 0.27% appreciation of the USD against SGD over the period, in SGD terms, the S&P 500 (+5.42%), Nasdaq (+8.63%) and GGL (+3.05%) posted strong gains, with the SOXX Semiconductor ETF rising ~23.6% against a 40% increase in the previous month, despite ongoing headwinds including infrastructure bottlenecks, rising input costs, and geopolitical risks. Our diversified positioning captured the sector’s upside through holdings such as Broadcom and TSMC, each rising over 7% and 10% respectively.

During the month, we exited United Rentals, following a strong earnings-led rerating, reallocating into Hyundai Rotem (Korean defence contractor & manufacturer of the K2PL, next-generation anti-drone Main Battle Tank) after a price correction to gain exposure to the thematic increase in geopolitical defence spending. Performance was supported by Eli Lilly (+18.59%), Naura Technology (+17.4%) and Microsoft (+10.8%), while Netflix, Tencent, and RELX PLC weighed modestly on returns. While earnings momentum remains constructive, persistent geopolitical uncertainty and elevated core inflation warrant continued selectivity and discipline as markets transition from liquidity driven gains toward earnings dependent performance.
